Cohen & Steers Wins AsianInvestor Asset Management Award for Global Realty Focus

NEW YORK, June 10, 2019—Cohen & Steers has earned the 2019 Real Estate Investment Trusts Award from AsianInvestor for the outstanding performance of its Global Realty Focus strategy. The award was presented on May 22, 2019, at the 14th Asian Investment Summit in Hong Kong.

The Cohen & Steers Global Realty Focus strategy has outperformed the FTSE EPRA/Nareit Developed Real Estate Index over the one-, three- and five-year periods. According to Mercer’s Global Investment Manager Database, the strategy produced the best return and reward/risk ratio in its category over one and three years. It was ranked top three in information ratio and has performed consistently with low standard deviation.
