The source of all distributions paid by the Funds, including net investment income is subject to change. A return of capital occurs when some of the money that you invest is paid back to you and should not be confused with "yield" or "income". Distributions from a Fund's investment in real estate investment trusts (REITS) and/or master limited partnership (MLPs) are attributed to various sources including net investment income, capital gains, and/or return of capital based on the prior year breakdown on the distributions from the REIT and/or MLP securities held by the Funds. The Funds generally will receive from these companies a final determination as to the source of distributions early next year.

Income as determined under federal income tax regulations differs from GAAP. As a result, distributions are subject to recharacterization for federal income tax purposes. The final tax treatment of all Fund distributions will be provided on Form 1099-DIV, which is mailed after the close of the calendar year.
